1. Executive Summary

MetaMoolah is an innovative token built on Polygon/Ethereum, designed to bridge cryptocurrency with immersive online casino gaming and P2E (play-to-earn). With an engaging roadmap and carbon-neutral approach, MetaMoolah aims to become a leading metaverse-integrated gambling and entertainment ecosystem.

2. Vision & Market Opportunity

- Capitalise on the booming online gambling sector (projected to be \$127B by 2033).
- Merge blockchain tokens, NFTs, and metaverse logic for immersive experiences.
- Turn casino gaming into rewarding, community-driven experiences.

3. Platform & Use Cases

- **In-platform currency:** Use MM tokens for bets, NFT purchases, VIP access, and DAO voting.
- **P2E rewards:** Win tokens through gambling, mini-games, or special events.
- **NFT benefits:** Special access, ticket to events, bonus spins, and airdrops.
- **Metaverse integration:** Future 3D casino environments using VR/AR.

4. Token Details & Mechanics

Total Supply: 1 Trillion MM tokens (customizable).

Token Allocation:

- 30% — Locked liquidity
- 15% — Exchange listings & reserves
- 10% — Development team (12-month vesting)

- 10% — Airdrops/community incentives
- 20% — Pre-sale rounds & public sale (5/10/5%)
- 5% — NFTs utility

3. **Exchange Expansion** – Apply to CoinGecko & CoinMarketCap; NFT collection drop; CEX listings.
4. **Platform Buildout** – First mobile app; smart contract audit; casino MVP; education portal.
5. **Metaverse Phase** – Metaverse casino launch; global MVP user base; community foundation to support global causes.

- **NFT Utility:** Premium minting, VIP access, live event tickets, token rewards, and bonuses.
- **Sales Allocation:** 75% to liquidity, 20% to dev, 5% giveaway to first owners.

- Standards: ERC-20 (Token), ERC-721/ERC-1155 (NFTs), Chainlink VRF for randomization

Smart Contracts:

- Token Contract (MM): ERC-20 with anti-whale mechanics
- NFT Contract: Supports metadata, rarity attributes, dynamic on-chain rewards
- Casino Logic Contract:
 - On-chain randomness via Chainlink VRF
 - Game result auditability
 - Payout enforcement via vault mechanism
- DAO Contract: Voting weight based on staked MM or NFT ownership

Wallet Integration:

- Web3-enabled wallets: MetaMask, TrustWallet, Coinbase Wallet
- Mobile DApp browser compatibility
- WalletConnect v2 support

Security & Infrastructure:

- Audit Partner: Certik/SolidProof
- Multi-Sig Treasury Wallets (via Gnosis Safe)
- Continuous Penetration Testing via white-hat bounties
- Hosted on IPFS for decentralized static content (e.g., whitepaper, contracts)

- Chainlink for randomness, price feeds
- On-chain Oracle access for cross-chain asset validation
- External API for KYC/AML (Jumio or SumSub compliant)
